The UNCRPD trainings



- Trainings for legal and policy practitioners since 2011
- Past EU funded project 2016-2019: contracts no. VC/2015/0815, VC/2016/0691, VC/2017/0636 and VC/2018/0598
- REC Programme (2014-2020)
- In cooperation with EDF and EFC
- Consistent support of the CRPD Committee, OHCHR and EJTN (incl. the judicial training institutes who compose the network)
- Involvement of disability law experts and NGOs advocating/litigating the rights of persons with disabilities
- Accessiblity





Methodology of the trainings



6 seminars per year: 2 for legal practitioners, 2 for the members of the judiciary and 2 for policy practitioners

30-40 participants per event

Selection criteria

Interactive presentations and workshops/case studies

Different lanaguage formats:

- English as the first seminar language
- German, French, International Sign language/captioning at least once per year
- Other languages covered: Spanish, Italian, Czech, Polish, Bulgarian

One live streamed event per year





UNCRPD trainings



854 persons trainined face-to-face in 2016-2019 from all EU Member States among which:

- 210 judges
- 31 prosecutors
- 28 judicial staff
- 127 lawyers in private practice

84 persons with disabilities and 136 trainers (of the overall number of participants)

Number of documents produced: 182 presentations, 25 workshop materials, 51 case studies and 27 e-presentations.
