### Requirements for Applicants

The applicants have to comply with the legal requirements to be enrolled in Spanish graduate studies. Applicants for these scholarships must have previously applied for admission to the Master Program of their interest, which involves the payment of the prescribed fee, through this web:

### Selection Criteria

Each master program has a Selection Committee, which will rank student applications according with students':

1. Previous studies, academic records and Curriculum Vitae.
2. Economic situation, personal situation and scholarship statement of the candidate, granted or applied for economic reasons, properly accredited and other postgraduate studies. The recognized prestige of the university where the student was enrolled for his or her previous studies may be taken into consideration, as well as the expenses associated with travel and / or accommodation of the students.

### Regulations on Incompatibilities

These scholarships are compatible with any other type of scholarship, subsidy, or financial aid of the same nature, unless if the sum of both implies an amount higher than the tuition fee of the program.

### Types and numbers of scholarships

The number and type of scholarships by program are shown at the **Appendix**.

**The scholarships will become effective during the first academic term.**

Therefore, they will only cover the cost of credits enrolled for the first time.

### Obligations of the awarded students

To pay the reservation fee within the time limits and formalizing the enrollment in the form of an installment payment of all tuition credits assigned to the subjects of the Masters' program.

### Documentation

1. [Motivation letter](#), in which it may be included information about the applicant's economic and personal situation, duly completed and signed.
2. If applicable: financial aid and scholarships obtained by the applicant in previous studies, indicating the organization or the financial entity and level of studies at which they are intended and amount.

3. In the case of **Master in Civil Liability** declaration form indicating that the applicant meets the academic/research study profile. ([Declaration form](#))

- Second period: **from February 1, 2023 until March 31<sup>st</sup>, 2023. 2<sup>nd</sup> Award Resolution: from April 27<sup>th</sup>, 2023**
- Third period: **from April 1, 2023 to May 31<sup>st</sup>, 2023. 3<sup>rd</sup> and final Award Resolution: from June 20<sup>th</sup>, 2023**
